No proposal will be received unless made on proposal forms furnished by and delivered to the Alpena County Road Commission prior to the scheduled closing time for receiving proposals set forth above. Each proposal must be sealed and plainly marked with the name of the project, bid opening date, and bid opening time on the outside of the envelope.

The Board reserves the right to reject any or all proposals, to waive any irregularities in any proposal, or to make the award as appears to be in the best interest of the Alpena County Road Commission.
